① Do not litter empty cans & cigarette butts etc.

The littering of empty cans and cigarette butts is prohibited. Litter is trash that includes beverage containers such as cans, bottles and PET bottles etc., cigarette butts, chewing gum litter, paper scraps and other similar things which by disposing of incorrectly causes littering.

* Fines of up to 20,000 yen is payable by offenders



② Regarding the installation and management of vending machine collection bins

Vendors who sell food and drinks via vending machines are not only responsible for the installation of collection bins for empty cans, PET bottles and paper cartons etc., they are also responsible for ensuring the surrounding area is not littered with cans.

* Offenders may have their names etc. disclosed to the public.



③ Pick up after your pet

When on public property or other people's private property, remember to pick up after your pet cat or dog.

* Fines of up to 20,000 yen is payable by offenders



④ Keep your dog on its leash when walking your dog

When walking or exercising your dog at parks or on public property, use a leash or a retractable leash to keep your pet under control.

Letting your dog off the leash to walk or exercise it is extremely dangerous as it equates to letting it run loose and it may injure other dogs or people.



⑤ Keep your pet cat on your own premises as much as possible

Try to keep your pet cat on your own premises as much as possible. This will help to prevent any trouble with the neighbours, traffic accidents and infectious diseases.

⑥ Graffiti is prohibited

It is prohibited to graffiti public places & establishments, other people's buildings & walls etc.

* Fines of up to 50,000 yen is payable by offenders

⑦ **Observe the rules when disposing of garbage at collection stations**

People disposing of garbage & recyclable materials at collection stations should ensure they follow the rules and sort their garbage appropriately prior to disposing of their garbage on the correct day and at the right time.



⑧ **You are responsible for looking after your own property**

In the event litter is thrown onto your property, weeds or other things render the surrounding environment unsightly, you as the proprietor are responsible for appropriately disposing of them.



⑨ **When smoking, beware of its health implications for others and have good smoking etiquette**

- Be fully aware of the health implications for others when smoking & make every effort to cut down on smoking.
- Make every effort to cut down on smoking whilst walking or riding a bicycle.
- Make every effort to carry an ashtray with you when smoking outside.

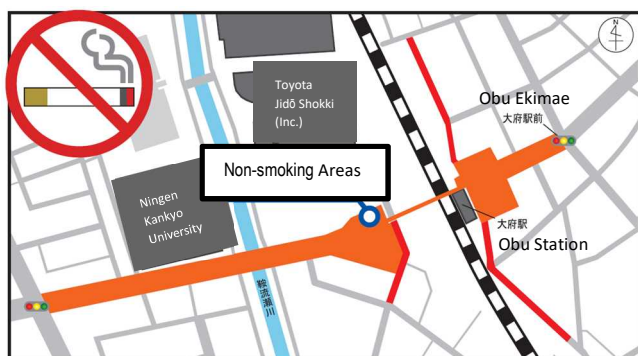
⑩ **Designated Non-Smoking Areas**

Smoking whilst walking and smoking whilst riding a bicycle in areas designated by the Mayor as non-smoking areas is prohibited.

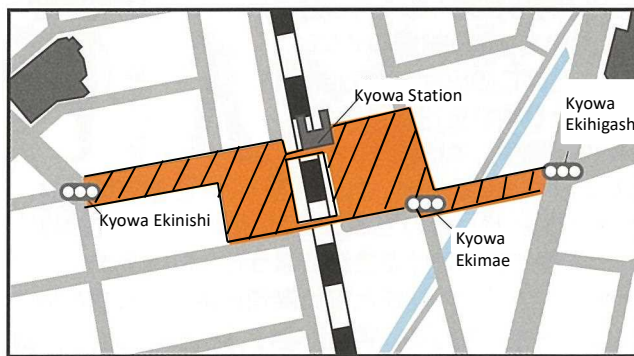



TOTAL SMOKING BAN (As of 1st February, 2011)
